

This coursebook features a case-study and problems approach in which the principles of estate planning are first introduced and then demonstrated through student analysis of short exercises and simulated client situations. A forms supplement on CD is an additional tool for giving students practice with drafting exercises. Features: Case studies in every chapter emphasize problems that arise in the actual estate planning process. Exercises and case studies explore a broad variety of issues, and allow great flexibility in teaching. Each chapter begins with an overview of topics covered, followed by a more detailed discussion of legal doctrines and principles. An electronic forms supplement in CD conveniently supports a drafting component to the course. The ordering of topics treats fundamental issues first, more complex issues later. Flexible organization presents a life-cycle progression reflecting the changing needs of clients from youth through old age. Coverage of federal tax issues supports those who wish to teach it and can be taught or omitted at the professor's discretion.
